Enterprise Bargaining at Macquarie University

Your current Macquarie University Enterprise Agreement expires this year on 30 September 2014.

This means that your pay and working conditions (including all leave entitlements, workload clauses and restructure processes) will soon be up for negotiation.

Your union, the CPSU/PSA, places great importance on the ideas and input of members in Enterprise Bargaining. We will be gathering information from CPSU/PSA members both before and throughout the negotiations to ensure that the bargaining claims reflect your voice.

Some questions for you to consider in our developing a log of claims:

- What are the conditions in your current enterprise agreement that you consider are important to your working life that must be preserved?
- Are you having difficulty obtaining variable hours so that you can enjoy a flex day or rostered day off? Why is the opportunity of working variable hours not available to all staff at Macquarie University?
- Is your workload manageable? How many hours of unpaid work are you putting in? Are you taking your lunch hours?
- Were you over looked for a promotion? Do you believe the selection procedures and the appeals against non-appointment meet your needs?
- Do you believe you have job security? How many restructures have you been through in the last few years?
- Are you still working on a contract or casually employed when you know the ongoing work and funding is there?
- Are there any other matters you would like raised during the Enterprise Agreement negotiations?
- Do you have a disability? Are you receiving adequate support in your work environment?

In order to collate your thoughts and ideas the CPSU/PSA will be holding discussion groups, or "Listenings" (see right).

Take the opportunity to make sure your pay and conditions meet your expectations and participate in our Listenings. Our first one is scheduled for:
