(The statement shall not exceed 200 words.) Lodgement of statements closes on 18/02/2018 at 12:00pm AEDT

**NOTE:** Should no or insufficient nominations be received, the CPSU(SPSF) will apply to the Federal Court for a declaration under s 323 of the *Fair Work (Registered Organisations) Act* 2009 that the sub-branch has ceased to function effectively and for orders that would lead to the removal of the sub-branch from the rules.
