# Coronavirus risk: Union demands the closure of TAFE libraries across the state

This morning CPSU NSW staff and delegates met with TAFENSW to discuss its contingency plans for reducing the risk of exposing staff and students to the Coronavirus. We strongly pressed the point that continued operation of the libraries places our members, staff and students at risk of contracting and transmitting COVID-19.

We remain deeply concerned at this time that TAFE has made a decision to keep libraries open.

We have written urgently to Managing Director Steffen Faurby, earlier today, seeking his clarification that TAFENSW will be following the directive of the Prime Minister to close all libraries by midnight tonight 25 March 2020 <u>HERE</u>
